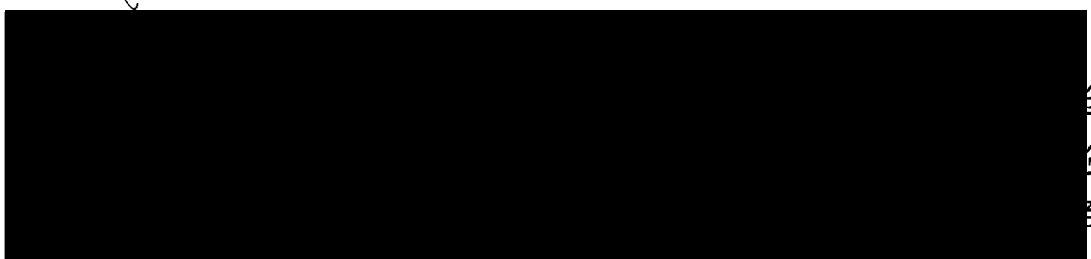

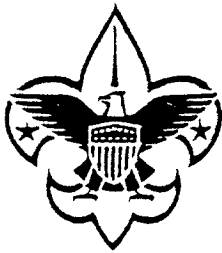

## Vice unit role in officer's case reviewed

The Austin police internal affairs division plans to investigate why vice officers did not arrest a lieutenant suspected of public lewdness in an adult bookstore and whether their superiors waited a month to report the matter, officials said Wednesday.

Internal affairs officers are investigating allegations that Lt. David Crowder was engaged in a lewd act while in a video booth at the Oasis bookstore, 9601 N. Interstate 35, on the afternoon of Jan. 9, police officials said.

A separate investigation may follow to determine why Crowder was not arrested and whether vice squad supervisors — Lt. Jerry Slotton and Senior Sgt. Byron Cates — immediately reported the matter, said Lt. Roger Napier, head of the internal affairs division.

Crowder, 43, has been on the force nine years and has helped su-

perwise officers working in the Repeat Offender Program since September. He is restricted to office duty until the internal affairs investigation is complete.

Crowder declined to comment until the investigation is finished.

Assistant Chief Ray Sanders said vice officers said nothing to the man in the video booth, whom they recognized as a fellow officer, and did not arrest him. Vice officers were inside the store as part of a routine investigation into activity inside adult-oriented businesses, Sanders said.

Crowder was off duty at the time police say he was seen at the bookstore. A person commits an act of public lewdness if he engages in sexual conduct in a public place, or, if not in a public place, is reckless about whether someone else is present who may be offended or alarmed by his act. Vice squad officers routinely visit bookstores, and public lewdness at there are

not uncommon.

"He didn't even know they observed him, and (they) walked away," Sanders said.

According to Napier the vice officers told Slatton and Cates they saw Crowder in the bookstore.

Police Chief Jim Everett learned of the incident and referred it to internal affairs officers on Feb. 13, Napier said. Napier said he did not know how Everett was notified. The chief is on vacation this week

and could not be reached for comment.

Slatton said Wednesday he could not comment because the investigation is not finished.

Cates is being investigated by internal affairs on charges of excessive force, an allegation that he took a prostitute to Las Vegas, Nev., and an incident in which he and several friends went to a massage parlor. His supervision of the vice squad is also part of the investigation.

Cates, through his attorneys, has denied the allegations. He could not be reached for comment Wednesday. One of his attorneys, Gregory Zaney, said he did not know about the Crowder investigation.

Sanders said he did not know why internal affairs officers were not told of the accusations against Crowder until more than a month later, but added: "I suspect it was because of the nature of the incident." Napier said investigators will ex-

amine whether Crowder violated police regulations or any state laws. "If there is anything else that needs to be addressed," such as how the incident was reported to police officials, a separate investigation will follow, he said.

Internal affairs officers were expected to complete the Crowder investigation by the end of next week and forward their report to Everett, who will decide whether disciplinary action should be taken.

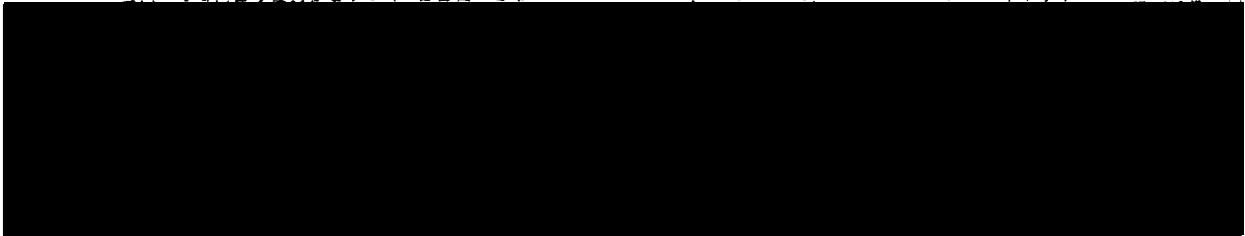

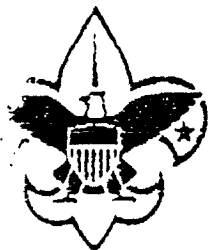
