As per your request I am writing this letter to inform the Boy Scouts of America that I was sexually molested by George Wayne Hughes for a period of three years from 1961 thru 1963. At the time Mr. Hughes was an assistant Scoutmaster and later became Scoutmaster. At the writing of this letter, Mr. Hughes is approximately 49 years old. Upon request from your office, I will testify, give written statements, or whatever else is necessary to keep Mr. Hughes out of the Boy Scouts.
