The enclosed clipping would indicate that this judgement was correct and I would now suggest that we put him on the list.

He has a history of moving from town to town and trying to become part of the program. Over the last few years he has lived in Longview, Marshall, Kilgore, and now Crockett. I do not know him personally, but our two field directors have both met him and sort of kept up with him. If I learn more about him, I will certainly send you the information.

Probation is given local man

Jeffery Lloyd Bump of Crockett pleaded guilty to indecency with a child and was given a probated sentence in district court Thursday.

Bump was given a five-year probated sentence and fined \$250. He was also ordered to attend the psychological counsel program as designated by his probation office and he must not be alone with any juveniles other than members of his family.

Bump could have received up to 20 years in the department of corrections and a fine of up to \$10,000.

The defendant waived his right to a trial by jury and for representation by an attorney.

District Attorney Don Gordon, said he believed the punishment was reasonable "under the circumstances because he (Bump) will be forced to seek some kind of treatment. That is a better solution than sending him to TDC."
