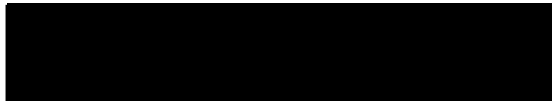
I had sexual advances made towards me on three different occasions. Once on a camping trip, and twice in his house, with no other scout leaders present. It happened between summer and fall

Dear Paul,

Through Second Assistant, our Scout Executive, you requested a summary of my interviews which led to our requesting a confidential listing for John F. Hollander, Jr.

About two years ago, the mother of a ten-year (not registered in Scouting) in our church brought to my attention that her son and a friend encountered, while camping in a state park, questionable moral behavior by a Scoutmaster. The Scoutmaster was camping with his Troop and turned out to be Mr. Hollander. Our Council Executive, Mr. G. J. Perrin, was on vacation at the time. I consulted the concerned District Executive, Mr. Charles Williams, then interviewed the two boys in their homes. The two mothers and one father (the other father is partially separated from the family) also volunteered their comments on their sons' reactions to the incident. I also talked by phone with a detective on the Mt. Ephraim police department. Although inferences were made by Hollander to many acts of moral turpitude, no actual incidents could be proved or cited by the people interviewed. The only action taken was to call Hollander to the Council Service Center for an interview with Charles Williams and myself. We told him of the rumors but made no accusations. He suggested that models

department on his part would be in order. No further action was taken.

Last fall Charles Williams heard rumors that Hollender was again having boys overnight at his room without any adult present. Hollender denied this allegation when confronted with it at a Caspary.

The latest series of incidents, well substantiated, has been covered in your discussions with Lee Barrett. I conducted the interviews on a Saturday morning because he was having a well-deserved week-end holiday. Basically, the Troop Committee Chairman (Troop 105), the Head of the institution, [redacted] boys, and parents involved were present. Lee pointed out to them (Chuck Williams was again with me) the procedure to be followed, including the needed letters for substantiation, after they had told us their side. You are in possession of these details.

Please do not hesitate to contact me if I can be of further help to you. I certainly hope our next association will be on more pleasant subjects.

Gentlemen;

The Committee of Boy Scout Troop 105 of Collingswood, and Camden County Council New Jersey, has dismissed John Hollander from his duties as Troop Scout Master.

The reason behind this action, stems from complaints by four boys who were or are members of Troop 105. These complaints are a direct result of sexual advances by John Hollander, on an individual basis, toward each of these boys. Written statements by each boy are being submitted, along with this letter, to substantiate our decision.

John Hollander accepted his dismissal like a gentleman, never questioning or disagreeing with our decision. His deepest concern was in two areas. One was for his father and Brother, the other was that the Scout Office would not black-ball him for life. The Committee is sympathetic with John's concerns and therefore is accepting a letter of resignation from John for the reason of bad health, which he most definitely has; arthritis of the back and rectal bleeding.

The Committee also feels that John's 17 years of scouting should not come to an immediate end. It is our recommendation that John be allowed to serve in a capacity as a Scouter on a committee at Council level or on any special projects which would not bring him in direct contact with boys, if this were possible. John's knowledge of scouting, then would be of some value to Council and at the same time, Council would be providing a human service to a scouter who needs to express himself in a constructive manner.
