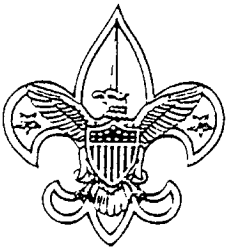

Teen Gets Probation For Child Indecency

BELTON — Mark Eugene Narmi, 17, of Killeen entered a plea of guilty Thursday in 264th District Court to a reduced charge of indecency with a child by contact.

Judge Jack W. Prescott accepted the plea and placed Narmi on unadjudicated probation for five years.

Narmi originally was indicted for aggravated sexual assault of a girl, 10, on Sept. 30, but the charge was reduced to indecency with a child in a plea-bargain agreement.

■ Cleveland Gossett, 19, of Temple pleaded guilty to indictments charging him with possession of cocaine and credit card misuse and received from Judge Prescott two concurrent 10-year prison sentences.

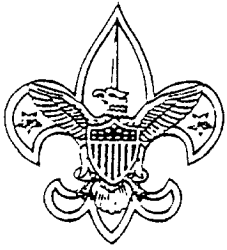
In addition, the judge ordered Gossett to pay \$1,345.88 restitution in connection with the use of a stolen communications credit card.

■ William L. Boland, 30, of Temple pleaded true to allegations in a state motion to revoke a prior five-year probated sentence for driving while intoxicated.

Judge Prescott took the plea, revoked the 1986 sentence and sent Boland to the penitentiary for three years.

The judge also suspended Boland's drivers license for 18 months.

Records show Boland violated terms of the probated sentence by being arrested for public intoxication in February and failure to avoid injurious habits.

Re: Mark Narmi

I have been checking weekly on the above individual, and have not been able to find out anything about the disposition of the alleged charges against him.

As I mentioned to you on February 8, Mark Narmi was a "Boy Scout". You and I removed him from the BSA rolls then. His Scoutmaster also visited with Mark and his mother and stated that Mark would have to withdraw from the troop. He did withdraw and has not been to a meeting since.

Gordon Plumlee, the Scoutmaster, told me that everything is being kept very quiet. There has been nothing in the news media. Narmi's mother did tell Gordon early on that their lawyer had instructed them to speak to no one about the matter.

Until such time as more information becomes available, there's not much we can do.
