Twp. Girl, 13, Assaulted; Asst. Scoutmaster Accused

WASKING RIDGE—A 20-year-old assistant scoutmaster from Woodruff Township, was arraigned Friday before Magistrate Herbert M. Heaney on a charge of assault with intent to rape.

Released on \$300 bail was Tibor J. Koncz of 182 Woodruff avenue, Avenel, accused by police of attacking a 13-year-old girl in Liberty Corner last Thursday afternoon.

The victim, a private school student, was walking home from a school bus stop when she was assaulted.

In reconstructing the incident later, the girl told police that as she was going along Douglas road,

a car passed her and pulled into a private lane a short distance away.

When she approached the spot, the girl said, the driver of the car, later identified as Koncz, asked if she were going up the road.

She told him she was and he said her parents had asked him to drive her in.

The girl refused to accompany him, police said, and he turned as if to go back to his car.

She then started up the private road, and looked back to find the man was running after her.

The girl said she started to flee, but Koncz overtook her, the

two... fell to the ground. Her... attracted her father... on his way down the... and he chased after...

...called to Koncz to stop... apparently realizing... came back, police...

Bail was initially set at \$1,000 by police and Koncz was jailed overnight on lieu of bail.

The amount was reduced at Friday morning's arraignment by Judge Heaney and Koncz's father posted the \$300.

Police said it was apparently a first offense for Koncz, a stock clerk. He told police he was in this area looking for the "watching" Scout Reservations.
